

## NOTIFICATION

**No.F.11/54/Admin/2026-FCCP.** In pursuance of the **austerity and fuel conservation** measures announced by the Federal Government vide Notification No.7-2/2026-Min-I dated 09.03.2026, and in view of the prevailing global and regional situation, the Federal Constitutional Court of Pakistan, while keeping in view its functional requirements being newly established apex Court of the country, is pleased to adopt the following **measures**, as far as possible, with immediate effect until further orders:


- i) **Maximum Fuel Reduction:**  
Maximum reduction of fuel provision for official vehicles in use of the Federal Constitutional Court of Pakistan;
  - ii) **Four-Day Workweek:**  
Observance of a four-day workweek (Monday to Thursday); Friday to Sunday as Holidays.
2. All concerned shall ensure strict implementation of the above measures.
3. This issues with the approval of the Hon'ble Chief Justice, Federal Constitutional Court of Pakistan.
