## NOTIFICATION

**No.F.24/4/2025-FCCP:-** In pursuance of the decisions taken in the Full Court Meeting of the Federal Constitution Court of Pakistan held on 17<sup>th</sup> November, 2025, and with the approval of the Hon'ble Chief Justice, the following decisions are hereby notified for implementation.

1. It has been unanimously resolved that the Supreme Court Rules, 2025 are hereby adopted for the practice and procedure of the Federal Constitutional Court of Pakistan, mutatis mutandis, excluding Orders XI, XIII and XXXVII, until framing of the Rules of this Court.
2. Every cause, appeal, petition or matter shall be heard and disposed of by a Bench consisting of not less than two Hon'ble Judges, to be nominated by the Hon'ble Chief Justice. Appeals arising out of judgments passed by a Division Bench shall be heard by a Bench comprising not less than three Hon'ble Judges of this Court to be nominated by the Hon'ble Chief Justice.
3. Members of the Bar enrolled as Senior Advocates Supreme Court of Pakistan, Advocates Supreme Court, and Advocates-on-Record are entitled to appear as Senior Advocates, Advocates, and Advocates-on-Record before the Federal Constitutional Court of Pakistan provisionally, until further orders.


This Notification shall take effect immediately and shall remain operative until modified or superseded.
